What personal information is collected at our website and how is it used?

We only capture your personal details when you submit them to us. How will my information be used?

By providing your information, you are agreeing to receive the Genji Sushi email newsletter. You will have the ability to “opt-out” of our newsletter at the time of your registration on our Sushi Platter ordering system and through our contests and communications. By choosing to “opt-out” of our newsletter communications, you will not receive any other mailings from us unless you agree to. You are free to unsubscribe from the newsletter at any time. Genji, LLC. will not sell, rent or trade your personal information to others at any time. Non-personal data, statistics about use on our website, entries, traffic patterns, etc., may be shared by Genji, LLC. for internal purposes only and will not include any personal identifying information.

Except as required by law, Genji, LLC. will not pass your personal data to any outside organization for marketing, communication or solicitation purposes.

Surveys & Polls

Occasionally, Genji, LLC. customers may be asked to participate in our research through surveys and polls. Participation in these events is voluntary. By participating in our surveys and/or polls, you may be asked to supply personal information, such as your demographic information and lifestyle preferences. Since all information is voluntary, you can choose the information you disclose to Genji, LLC. through your responses.
